Lawrenceville Kennel Club is looking for an Event Coordinator. The Event Coordinator will be the single point of contact for vetting possible LKC participation in events outside those of our AKC **Conformation Show, Obedience** and Rally Trials. **Events can include those** sponsored by outside persons/ organizations (e.g. Pawfest, Canine Meals on Wheels). Or they may be sponsored by LKC (e.g. seminars, RDO Day). The Event Coordinator should be contacted by anyone who becomes aware of an event that has potential for LKC participation. Any solicitations

from event giving organizations should be referred to the Event Coordinator.

Upon learning of an event, the Event Coordinator will gather whatever information is necessary for LKC to be considered for participation. This information will be communicated to the Board of Directors (BOD) for review. Upon approval of the BOD the Event Coordinator, with the help of the Club Secretary, should query the membership to ascertain if there is enough interest and resources available to support LKC participation in the event.

If there is adequate interest and resources to support LKC participation in an event, the Event Coordinator will hand-off the organization and implementation of LKC participation in the event to whoever steps up and assumes that role. The Event Coordinator is not expected to be the person who organizes and implements the resources for an event, unless they so wish.If the event is not supported by the BOD, member interest, or club resources, then the Event Coordinator will advise the membership of such. # **Board Meeting Minutes**

### SEPTEMBER 20, 2016 BOARD MEETING MINUTES

The President opened the meeting at 7:34 pm. All members were present.

The minutes were approved as published.

### Treasurer:

Balance \$46,766.56

The Treasurer stated that the officers and directors insurance has been paid.

The Treasurer stated that Settlement One between the Cluster Clubs is completed by three days after the show and shared with club. Settlement Two is the final settlement between the Clubs.

### **Committee Reports:**

Membership; The Membership Directories are available. There are 6 applications for the next general meeting. Membership Chair asked that the changes to the membership form be reviewed and approved at the Board meeting tonight.

Training: Orientation night went very well. The CGC and AKC S.T.A.R. puppy classes are full. There is a request from the Training Director for Rally signs and that the instructors have LKC shirts. It was noted that the Board has previously approved shirts for instructors.

Gail LaBerge to investigate the cost of Rally signs both laminated and unlamented. Judy Wilson offered to find out the cost of having the signs laminated, Ouida Blackwelder stated she has a laminating machine and could possibly do the laminating.

George Cooper brought up the use of pinch collars in classes. After much discussion, the Board agreed that the use of pinch collars in obedience classes will be left to the decision of the Training Director and Training Instructors. There will be no pinch collars used in Conformation Classes.

### Old business:

Two tours of the UGA Veterinarian School have been arranged. The first will be October 4, Tuesday, at 11:00 am, and Oct 8, Saturday, at 11:00 am. Members of LKC may invite a guest.

Meals on wheels for Canines: Susan Saulvester has not been able to check on this at this time.

Show: The show Chair stated the premium for the February Cluster is due next week. Those donating trophies need to get their pledge form to the Trophy Chair by September 27, 2016. She stated MBF is going up slightly on their fee per dog, to ten cent per dog.

A discussion on giving new title ribbons was held. The photographer gave the Show Chair a rough estimate of 60-100 new titles per show. The Board voted to offer new title ribbons that will have the LKC logo, New Title on the middle ribbon, and will be a rosette with two streamers yellow and the middle streamer blue.

Hospitality: Ruth Baranowski will step down after the February 2017 show as the Chair. It will be announced at the September meeting that a new Chair needs to be in place for August 2017. That person needs to shadow Ruth at the February show in order to understand what needs to be done.

Discussed the LKC Facebook page and the types of pictures to place on it. The page content is monitored and restricted and anyone posting must be approved.

Website, The reference to the building has been changed to meeting and training location.

The President asked the Board to look at the new website that is in progress. He gave them an address to do so. He wants the board to look at how the new site works and feels.

The President feels LKC needs an events coordinator. They would not have to necessarily be at every event, but would do the initial research to see if an event would be something that LKC should participate in. He will bring this topic up at the next LKC general meeting.

Membership form: The Membership Chair presented a new form. A motion was made to accept the form as published with corrections by Susan Saulvester, Seconded by Casey Kilcullen-Steiner. Motion passed.

October meeting: This meeting is the awards dinner. A restaurant is needed that has a meeting area. The President stated that the Old Towne Tavern has worked well in the past and he will ask at the September General Meeting if there are any objections to using that restaurant this year. The President will ask at the September General meeting for someone to coordinate.

### **New Business:**

Gail LaBerge asked permission to investigate a climate control holding area for club document. She is concerned that the Club will loose the Club's history if it is not retained properly and all together. She was given permission to investigate a storage facility.

Gail LaBerge gave information on AKC Canine Partners' meeting with the Gwinnett County Animal Welfare and Enforcement Center. The Shelter is interested in having some of their staff and volunteers trained to do basic obedience.

Susan Saulvester asked permission to request the membership to provide updated photos of the members and their dogs to go on the training building wall. She will send the Secretary a note to go to the membership requesting pictures.

Susan Saulvester believes that LKC needs a committee to look at the LKC code of ethics for updating. The President will bring this up at the September general meeting. He will announce that a committee is being formed with Casey Kilcullen-Steiner as Chair.

Susan Saulvester asked that insurance coverage be placed on the October Board agenda. She is to send to the Board an e-mail she received from the company insuring LKC.

George Cooper asked about new mats for the building. The President can start the process of acquiring new mats. The President is to provide a layout showing what the initial pricing is based on. The President believes \$5,000 would be the top end of mat purchase.

The Building Managers who do not feel they should be in charge of stocking the new refrigerator with drinks and water contacted Ouida Blackwelder. The President to ask at September general meeting if someone will do this job.

Ouida Blackwelder brought up the fact that the area at the Cluster now used for meetings by clubs needs to be blocked off. Discussion on how to do this, and decision made to block off with tape.

Meeting adjourned 9:15 PM.




